

Greening the Building Code Seminars - September 2008

The Building Officials' Association of BC in cooperation with the British Columbia Building & Safety Policy Branch, Ministry of Housing & Social Development and the Electricity & Alternative Energy Division, Ministry of Energy, Mines & Resources are delivering Education Seminars across BC in September 2008 [see attached Seminar Registration form and location schedule].

The purpose of the Seminars is to provide technical and regulatory information to building code enforcers, architects and designers, engineers, builders and others on the new green provisions in the BC Building Code. A new Part 10 has been added to the BC Building Code that includes new energy and water efficiency objectives. These new provisions will come into force on September 5th, 2008 in British Columbia. The seminars will be presented in afternoon sessions running from 1:00 pm to 5:00 pm in ten locations across the Province. An overview of the seminar program includes:

- On the residential side, the seminar presenters will explain the new insulation tables, water efficiency and equipment regulations and the Energuide 77 alternate compliance approach, including the Hot2000 computer modeling and recommended documentation reports and regulatory enforcement procedural steps involved.
- The details of the ASHRAE 90.1, 2004 version as an alternative compliance for large buildings will be explained, including the role of Letters of Assurance and other compliance issues.
- Other topics to be covered include, requirements under the BC Energy Act, the incentives available under the LiveSmart rebate and other programs. We will also highlight specific energy efficient, green building projects, which are underway and have been completed in the various seminar locations, where applicable.
- In the four lower mainland seminar locations, the City of Vancouver will explain their Green Building initiatives and new energy requirements. The City of Vancouver has been using the ASHRAE 90.1, 2001 version as a compliance alternative for several years.

Registration Instructions:

Seminar participants are requested to Register to reserve a seat at the various seminar locations by filling out the attached Registration form. Include your name and other information. Check off the seminar location of choice you wish to attend. Locations have limited seating, which will be allocated on a first registered, first served priority.
