

**FEES, FINES AND CHARGES
January 2012**

The Executive Committee, exercising its authority under the BOABC Act and BOABC Bylaws, has approved the following schedule of fees, fines and charges. This bulletin applies to all individuals, new members, members and certification holders effective **January 1st, 2012**. The BOABC fiscal year is April 1st to March 31st.

Unless otherwise stated, **all fees, fines and charges are subject to applicable taxes at the prevailing rate in effect at the time the fee, fine, or charge becomes due.** Payments must be remitted in Canadian funds and can be made by cheque or cash. All amounts noted below are for the 2012 fiscal year, including HST.
