TITLE: ANNUAL CONFERENCE (AGM) EDUCATION SEMINAR (ES) INVITE 4.4

POLICY:

The Zone Director for the Zone in which the Annual Conference (AGM) is being held, may recommend for approval of the Executive at their January meeting, that a former or retired member of the Association be given recognition where that member has performed outstanding service for the Association. Such recognition shall be in the form of an invitation to the Annual (AGM) Banquet. Other invitations are specified as follows:

1. Associations, with which the BOABC has close working relationships, shall be invited to attend the Annual (AGM) Conference at a specified luncheon during which they will be recognized for their support. The lunch will be complimentary for those affiliate representatives invited. Invitations will be decided upon by the President, in concert with the Conference Chair, and will include AIBC, APEGBC, the Building and Safety Policy Branch, POABC and ASTTBC. The Zone Director may also recommend, for approval by the President, any Local Building Industry Association that is prominent in the area in which the Annual Conference (AGM) is being held.
2. Other Building Official organizations, such as the International Code Council and Provincial Building Official Associations, shall be provided with invitations and complimentary registration to the Annual Conference (AGM), including the Banquet.
3. Life and Honorary members shall be invited to the Annual Conference (AGM) and be provided with complimentary Registration, including one additional Banquet ticket. In addition, Life and Honorary members shall be invited to the Annual Education Seminar (ES) and be provided with a complimentary Registration.
4. Retired members shall be invited to attend a complimentary luncheon at the Annual Conference (AGM).
5. Past Presidents, not currently serving on the BOABC Executive Committee shall be invited to the Annual Conference (AGM) and be provided with complimentary Registration, including up to one additional Banquet ticket. In addition, these Past Presidents shall be invited to the Annual Education Seminar (ES) and be provided with a complimentary Registration.

POLICY OBJECTIVE:

POLICY JUSTIFICATION:

The Association is founded and relies upon volunteer support, the involvement of members and the cooperation and assistance of other affiliated Associations and organizations. It is imperative that BOABC recognize these contributions at the Annual Conference (AGM), both as a token of appreciation and to serve as encouragement for continued support and assistance in the future.

The revisions and clarifications to the Policy, approved in January 2010, re-emphasize the importance and defines the scope of the invitation of guests at the Annual (AGM) Conference and, in addition, the Annual Education (ES) Seminar. For clarification, the revised policy also provides guidance for administrative purposes and to abide by fiduciary responsibilities by defining the limitations of the benefits provided, which do not include complimentary travel, accommodation, or other sundry expenses and programs associated with attending the Annual Conference (AGM) and/or the Annual Education Seminar (ES).
